Suggestion for utilization

If the products is used in a specialised grooming centre, the owner should provide the workers with adequate protections, if there are no other ways to avoid risks. (Ref: art. 43 D.Lgs 626/94; D.Lgs 475/92; art. 42 D.Lgs 626/94; artt. 5 e 44 D.Lgs 626/94).

In this case:

- during application, handling and rinsing phases, wear disposable gloves which protects both hands and forearms;

- use only tools which are deeply clean

Handling

Continuous exposure to detergents (soap, shampoo, liquid detergents) for professional reasons without the due protections can cause impoverishment of the hydro-lipid layer or to epidermis' horny layer, which are the natural defence of skin. This impoverishment can cause lesions to cutis, which is therefore more sensitive to external agents. Professional handling can therefore bring intolerances which can also worsen.

Measures to be taken in case of accidental leak

In case of accidental leak, gather the product with sand or sawdust, if appropriate, and put in containers suitable for lawful disposal.

Never put the product back in the original containers.

Wash the affected areas with water.

Do not re-use the leaked product.
