2 – COMPOSITION

Ingredient listing (INCI): the full list of ingredients is written on the packaging of the individual products in accordance with the Regulation (EC) No 1223/2009.

3 – HAZARD IDENTIFICATION

Instructions for use and warnings to be stated by Dir.: **WRITTEN ON THE PRODUCTS**

When used according to the producer's instructions, the product is safe for man and the environment.

Follow the instructions written on the packaging. Keep out of the reach of children. The contact of the undiluted product with the eyes may cause a moderate eye irritation. In case of eye contact, rinse immediately and abundantly with water. Ingestion may cause a mild irritation of the gastrointestinal tract. Do not apply on scalp that is harmed, irritated or affected by pathologies.

4 – FIRST-AID MEASURES

Eye contact: irritating when in contact with the eyes; remove contact lenses, if any, rinse thoroughly and abundantly with water; in case of persistent irritation, consult a physician.

Ingestion: in case of ingestion of considerable amounts of product, consult the nearest Poison Control Center.

5 – FIREFIGHTING MEASURES

Non-flammable product. In case of fire, use nebulized water, chemical powder, carbon dioxide.

6 – ACCIDENTAL PRODUCT LEAKS MEASURES

Gather the leaked product with rags, put it in suitable containers for disposal according to the regulations. Wash the contaminated areas with plenty of water. Do not put the leaked product back into the original containers. Never use the product after it has leaked out.

7 – HANDLING AND STORAGE

In case the employer identifies unavoidable risks by other means, he must make appropriate Personal Protective Equipment (PPE) available to the workers. The use of PPE supplied by the employer is mandatory.

In the specific case:

- Use work tools that have been accurately cleansed;
- Avoid nickel-plated tools;
- Avoid using costume jewelry;
- Wear a dust mask and proper goggles and gloves;
- Keep out of reach of children.

Optimal storing conditions:

- Store in dry and well-ventilated areas, at a temperature not below 5° C and not above 30° C, away from fire, heat sources, or electric devices in use.
- Keep the containers in a safe and upright position, avoiding the possibility of falls and/or collisions.

8 – EXPOSURE CONTROL/PERSONAL PROTECTION

Continuous exposure for professional reasons to cleaning agents (soap, shampoo, liquid detergents), may cause an impoverishment of the hydrolipidic film and of the corneal layer that make up the natural barrier of the skin. The impoverishment of this barrier can be the cause of skin lesions, which thus results in being more exposed to external agents. In such conditions, the handling of other products, which are normally used during the professional activity, without the due precautions, can be the cause of intolerances which may in time develop into more serious forms.

Stable product under normal conditions of use.

11 – TOXICOLOGICAL INFORMATION

The product cannot be considered toxic under the normal and predictable conditions of use.

12 – ECOLOGICAL INFORMATION

The work environment must be adequately ventilated, eventually through mechanical change of air. The areas in which emissions of vapors, gasses, dust, or the spilling of substances may occur must be separated and equipped with localized extractor units or collection systems.

13 DISPOSAL CONSIDERATIONS

The disposal of cosmetic products shall be in accordance with local regulations.

14 – TRANSPORT INFORMATION

There are no particular limitations concerning transportation, as the products are considered as non-dangerous goods.

15 – REGULATORY INFORMATION

The finished cosmetic products are manufactured and marketed as required by the Regulation (EC) No 1223/2009 and its further modifications.

They are specifically excluded from the scope of the national and EC legislation concerning dangerous preparations.

The need to subject workers to a health surveillance program (pre-employment and periodic visits) shall be evaluated by the Competent Physician on the basis of his specific knowledge of the risks.
